TERMS AND CONDITIONS

- EQUIPMENT CONDITION**
 The renter acknowledges that all equipment has been received in good working condition and agrees to return it in the same condition, except for normal wear and tear.
- VALID IDENTIFICATION**
 The renter must provide at least two (2) valid government-issued ID before the equipment is released. Examples: Driver's License, Passport, UMID, PhilSys ID, PRC ID, Postal ID.
- SECURITY DEPOSIT**
 A refundable security deposit is required before equipment release. The deposit will be used to cover damage to equipment, missing accessories, late return penalties, and cleaning fees.
- RESPONSIBILITY FOR LOSS OR DAMAGE**
 The renter assumes full responsibility for the equipment during the rental period. The renter agrees to pay for repair costs for damaged equipment, replacement cost for lost or stolen equipment, and replacement cost for accessories, batteries, chargers, memory cards, cases, mounts, cables, and other included items. Replacement value shall be based on the current market price of the equipment.
- PROHIBITED USE**
 The renter shall NOT: use equipment for illegal activities, sub-rent or lend equipment to another person, modify, disassemble, or repair equipment, operate equipment while under the influence of alcohol or drugs, and use drones in restricted or prohibited flight zones. Any violation may result in immediate termination of the rental without refund.
- DRONE-SPECIFIC CONDITIONS**
 For drone rentals: The renter is responsible for complying with all applicable aviation regulations. The renter must ensure safe flight operations. The renter assumes all liability for accidents, injuries, property damage, or violations resulting from drone operation. The rental business shall not be liable for any penalties, fines, or damages arising from drone use.
- WEATHER CONDITIONS**
 The renter assumes all risks related to weather conditions. No refund shall be provided for equipment damaged due to rain, flooding, strong winds, water exposure, or extreme temperatures.
- LATE RETURN POLICY**
 Late returns shall incur additional charges.
 - ₱100/hour per device.
 Failure to return equipment within 72 hours without communication will be considered unlawful retention and subject to legal action.
- CANCELLATION POLICY**
 - Cancellation more than 24 hours before rental date: Full refund.
 - Cancellation within 24 hours of rental date: Deposit will be forfeited.
 - No-show bookings are non-refundable.
- DATA RESPONSIBILITY**
 The renter is responsible for backing up all photos, videos, and files. The rental business is not responsible for lost footage, corrupted files, memory card errors, or data recovery.
- LIMITATION OF LIABILITY**
 The rental business shall not be liable for lost business opportunities, missed events, lost footage, consequential damages, or personal injury arising from equipment misuse.
- INSPECTION UPON RETURN**
 All equipment will be inspected upon return. Any damage, missing parts, or operational issues discovered during inspection will result in additional charges.
